

SUSPI Gymnasium: Indoor Pool Rules

Indoor Pool Rules: (click [here](#) for Afrikaans version)

Pool Users:

Gymnasium members, SUSPI clients, Department of Sport Science, Biokinetics Centre, Maties Sport Clubs (swimming, underwater hockey, water polo, biathlon and triathlon).

Rules:

1. All pool users must keep their relevant club/gymnasium membership cards with them, to be displayed on request.
2. All pool users must wear swimming caps when using the pool. Non-compliers will be asked to leave the pool area, and this could even result in a reduction of swimming sessions, or a complete ban on using the indoor pool facility.
3. Foodstuffs of any kind are strictly prohibited in the pool area, even during workshops or competitions. Fines: R50 per individual, R500 per club.
4. Pool users are not allowed to change within the pool area. All users should use the appropriate changing rooms. Users may, if they so wish, take a tog bag with them to the pool area. Fines: R20 per individual.
5. Any groups or clubs making use of apparatus in the pool are responsible for the removal thereof once their session/s are completed. This arrangement will ensure that subsequent pool users are not at an inconvenience. Non-compliance will lead to a reduction of pool sessions, or even a complete ban on usage of the facility for repeated offenders.
6. Mini-pool: This facility is only available to certain groups. It may only be used with permission and under supervision. Fine: R50 per individual.

You are kindly requested to abide by these rules to ensure that all users can enjoy this facility!

Swembad Gebruikers:

Gimnasiumlede, SUSPI kliënte, Departement Sportwetenskap, Biokinetika-sentrum, Maties Sportklubs (swem, onderwater-hokkie, waterpolo, tweekamp en driekamp).

Reëls:

1. Alle swembadgebruikers moet hul lidmaatskapkaarte van die spesifieke klub/gimnasium by hulle hou en op versoek aan die betrokke persoon toon.
2. Alle swembadgebruikers moet swempette dra wanneer die swembad gebruik word. Indien nie, sal u versoek word om die swembadarea te verlaat. Dit kan selfs lei tot die inperking van swemsessies, of 'n totale verbod op swembadgebruik.
3. Geen voedsel van enige aard word binne die swembadarea toegelaat nie – selfs nie tydens werkswinkele of kompetisies nie. Boete: R50 per individu, R500 per klub.

4. Geen swembadgebruiker mag in die swembadarea verklee nie. Alle gebruikers moet in die beskikbare kleedkamers verklee. Hulle sal wel, indien hulle so verkies, 'n sportsak na die swembadarea bring. Boete: R20 per individu.
5. Enige groep/klub wat apparate in die swembad gebruik, is verantwoordelik vir die behoorlike verwydering en wegpak daarvan, sodat dit nie inbreuk sal maak op die volgende swembadgebruikers nie. Oortredings in hierdie verband sal lei tot die inperking van oefensessies, terwyl herhaaldelike oortredings 'n totale verbod op verbruik van die fasiliteit tot gevolg sal hê.
6. Kleinswembad: Hierdie swembad is slegs vir spesifieke groepe beskikbaar en mag slegs met toestemming en onder toesig gebruik word. Boete: R50 per individu.
